

**PUBLIC NOTICE
2010 MUNICIPAL ELECTION
NOMINATIONS AND CANDIDATE CAMPAIGNS**

The Municipal Elections Act, 1996, as amended, provides that every person who proposes to be a candidate in the 2010 Municipal Election to be held on Monday, October 25, 2010 shall file a Nomination Paper with the Clerk.

The Municipal Elections Act further provides that a candidate's election campaign period for any of the following offices begins on the day he/she files a nomination for the office. No contributions shall be made to or accepted by or on behalf of the candidate and no expenses may be incurred by or on behalf of a candidate prior to filing the prescribed Nomination Paper with the Clerk. Money, goods and services given to and accepted by or on behalf of a person for his/her election campaign are contributions.

TAKE NOTICE that nominations will be received by the Clerk for the municipal election to be held on October 25, 2010 for the Offices of:

- **REGIONAL CHAIR**
- **REGIONAL COUNCILLOR**
- **MAYOR**
- **WARD COUNCILLOR**
- **WATERLOO REGION DISTRICT SCHOOL BOARD**
- **WATERLOO CATHOLIC DISTRICT SCHOOL BOARD**

Nominations for the Office of **REGIONAL CHAIR** or **REGIONAL COUNCILLOR**, **REGIONAL MUNICIPALITY OF WATERLOO** must be filed in the Office of the Regional Clerk, 150 Frederick Street, Kitchener, Ontario.

We are unable to provide candidates with information concerning **FRENCH LANGUAGE SCHOOL BOARD MEMBERS** at this time. A further notice will be published when such information is available.

Nomination Procedure:

1. The prescribed Nomination Paper may be obtained and filed in the Office of the Clerk:
 - (a) on any day from January 4, 2010 to September 9, 2010 when the Clerk's Office is open (see business hours listed below for each location).;
 - (b) no later than Nomination Day, Friday, September 10, 2010, during the hours 9:00 a.m. to 2:00 p.m.
2. The Nomination Paper shall be accompanied by a filing fee in cash, certified cheque or money order payable to the municipality in the amount of:
 - (a) \$200.00 for the office of Mayor,
 - (b) \$100.00 for any other office,
3. **The onus is on the candidate for election to an office to file a bona fide Nomination Paper.**
