Information Letter to Residents & Business Owners Reconstruction of Snyder's Road West – Foundry Street to Christian Street Foundry Street – Snyder's Road West to Charles Street

The Township of Wilmot is planning to proceed with the continuation of the reconstruction of Snyder's Road West from Foundry Street to Christian Street and Foundry Street from Snyder's Road to Charles Street. The contractor for this project is Steed & Evans Ltd. of St. Jacobs, Ontario. Work has been split into two stages and is expected to take two full construction seasons to complete. Stage 1 of construction was completed in 2024 and construction for Stage 2 (2025) is tentatively scheduled to begin in mid to late April, weather permitting and be completed late fall. Stage 2 is to include Foundry Street from Snyder's Road to Charles Street, and the remaining section of Snyder's Road West from Foundry Street to Mill Street. Stage 1 (2024) included Snyder's Road West from approximately Mill Street to Christian Street and has been mostly completed with final restoration expected to be completed this spring.

As you may be aware from previous public consultation/input meetings, the work consists of full road reconstruction including, new sanitary sewer, storm sewer, watermain, concrete curb and gutter, concrete sidewalk, concrete separated cycling lanes, road base and asphalt riding surface.

Traffic Concerns - Access to Businesses, Residences and Side Streets

The work will undoubtedly result in some inconveniences. Dust, noise and interruption of services cannot be eliminated entirely; however, the Contractor will make all attempts to minimize these whenever possible. All residents are advised to use caution in the vicinity of excavations and construction equipment.

Access to businesses, residences and intersecting local streets along Snyder's Road West and Foundry Street will be maintained to the greatest extent possible; however, disruptions will occur when construction activities are being completed directly adjacent to an entrance or local intersecting street. The Contractor will provide as much notice as possible to businesses and residences when construction activities are occurring adjacent to a property. If construction activities will make it such that you are unable to park in your driveway for a short duration (including overnight), you will be directed to alternate parking locations, such as an adjacent street. Parking passes will be circulated to impacted residents prior to the disruption.

There may be periods of time when traffic will need to travel on a gravel surface, as well as times when traffic will need to be controlled with flag persons. Temporary signage indicating businesses are "Open and Accessible" will be provided for all businesses within the active stage of construction.

Please plan for some delays and travel carefully through the construction zone. We request that when driving or walking through and around the construction zone that you follow and obey the construction traffic signage and traffic control persons for your safety and for the safety of the workers.

Pedestrian access will be available along Snyder's Road and Foundry Street throughout construction on at least one side of the road. Signage will be erected to direct pedestrians.

Grand River Transit (GRT) Service Changes

Garbage and Recycling (for properties within the active construction limits only)

During construction, for those properties that receive curb-side collection, we urge that you place your garbage in disposable bags (please avoid use of containers) at the curb along with your blue box, green bin and yard waste <u>prior to 6:00 A.M.</u> on your normal collection day. The garbage and recycling materials will be taken by the contractor to adjacent side streets for pickup by Waste Management. Blue boxes and green bins will be returned by day's end. **Please clearly mark your address number on your blue box and green bin to ensure proper return**. Canada Post Mail Delivery (for properties within the active construction limits only)

Properties that receive door service mail delivery should not be affected while construction is taking place. If you do experience a disruption in your mail delivery, please contact Canada Post at 1-866-607-6301 or go to their website <u>www.canadapost.ca</u> or contact the Township's representative.

Preconstruction Condition Survey

It is industry standard to complete preconstruction survey of buildings in the vicinity of imminent road construction activities. The preconstruction survey provides thorough documentation of the existing building condition, including any existing cracks or other visible structural or cosmetic defects of the exterior and interior of the property. If during or after the construction, residents/tenants experience any concerns with their property or suspect that damage has occurred as a result of the construction activities, the information from the preconstruction survey may prove helpful in resolving concerns.

Pre-Construction Building Inspections are to be completed prior to construction by Englobe Corp. on behalf of the Contractor. Individual property owners will be notified by April 4, 2025, informing them of the inspection request.

Restoration and Landscaping

The work on this project includes the reinstatement of affected driveways, sidewalks and any landscaping to preconstruction conditions or better. Only the affected portion of a driveway will be replaced/reinstated. **Prior to construction, the homeowner is also responsible for the removal and reinstallation of all underground sprinkler systems within the right-of-way.** Landscaping or planting materials within right-of-way should also be removed. If in doubt, please contact the Inspector or Contractor to determine if plantings will be disturbed during construction activities. The Contractor will maintain new sod for 60 days after placement. After 60 days, all sod maintenance and watering will become the property owner's responsibility, as it was prior to construction.

Temporary Water

As part of the reconstruction work the Contractor will be required to supply and install a temporary watermain throughout the construction limits. The ends of these temporary watermains will be continuously flushed to assist in maintaining water quality. Please do not tamper with these temporary watermain systems.

Working Hours

Normal working hours are Monday to Friday from 7:00 a.m. to 7:00 pm. Occasional weekend work may occur from time to time.
