#### Part 4 - Verification by Owner

I hereby verify that:

- 1) The alteration of equipment discharging a contaminant of concern to the atmosphere described in Part 2 of this form meets the requirements of the conditions of the ECA identified in Part 1 of this form which authorizes the alteration;
- 2) The alterations only pertain to emergency generators or venting for odour control;
- All reasonable measures will be undertaken to minimize odorous emissions and odour impacts from all potential sources at the Facility;
