of Erbs Road**



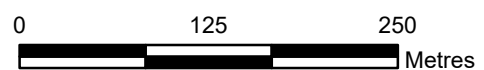


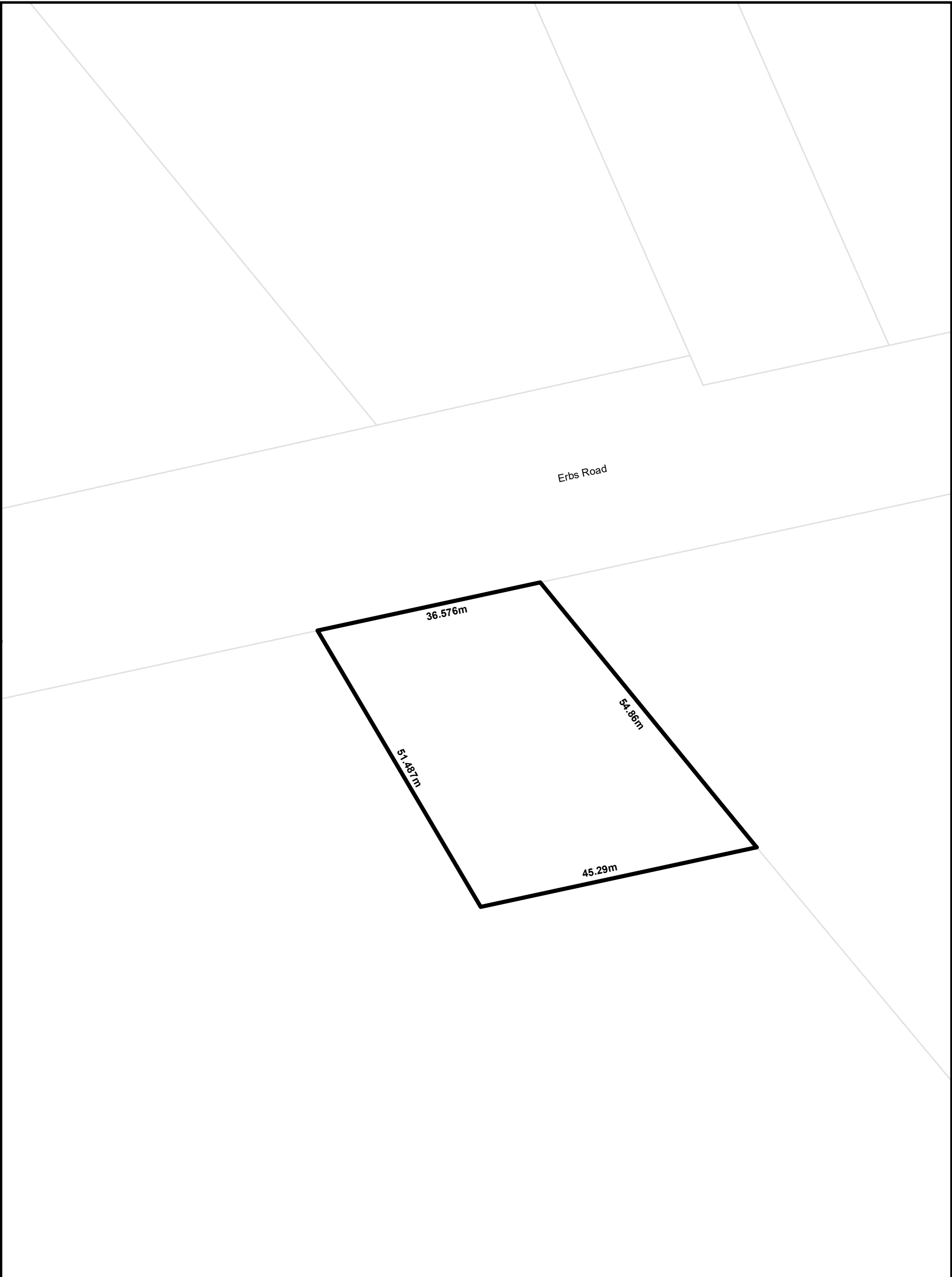

 of Erbs Road**



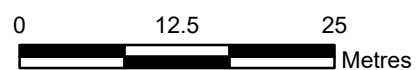


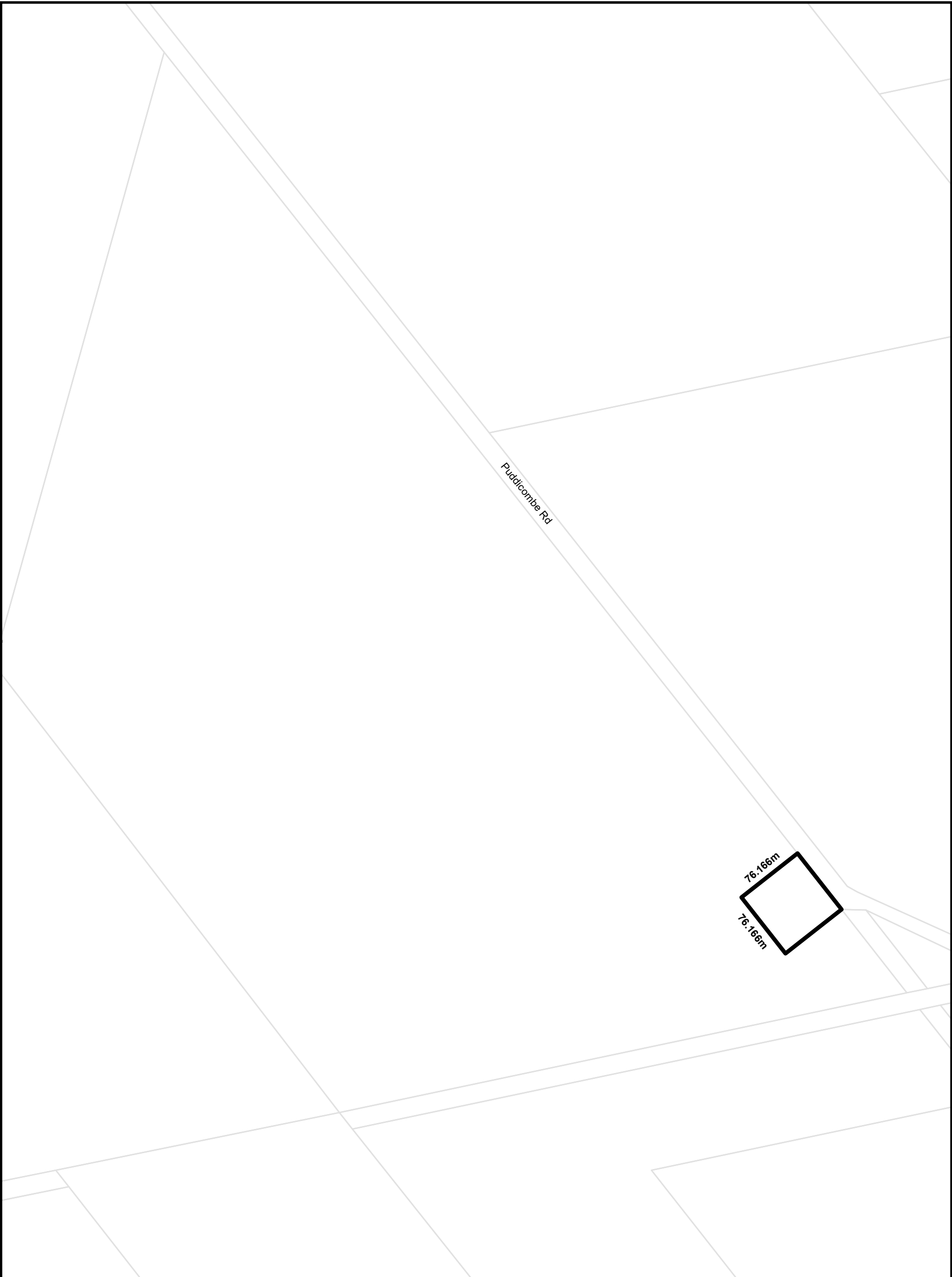

of Snyder's Road**



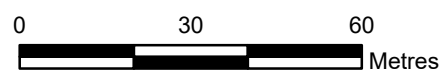


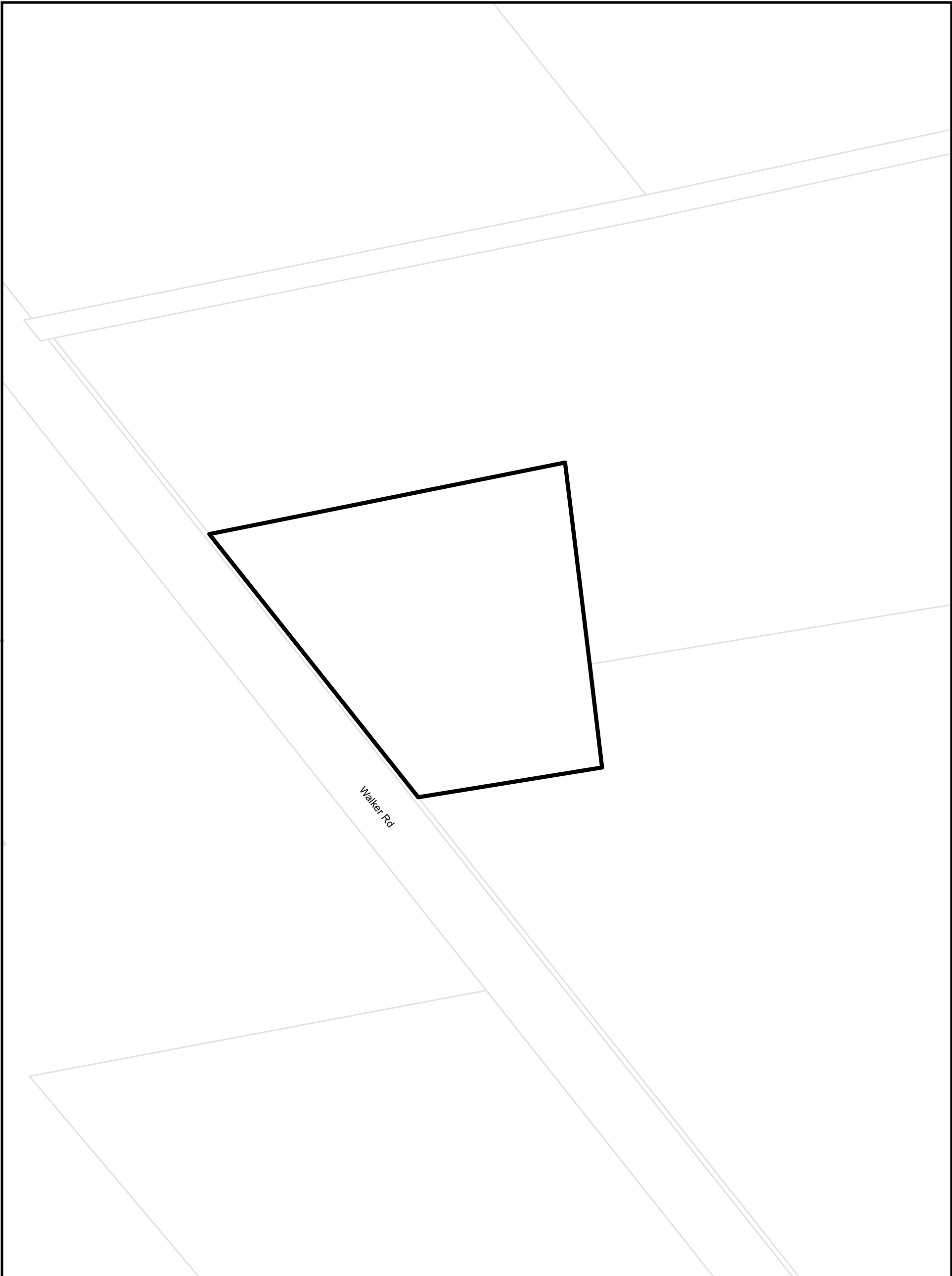

## Lot 24 West of Perth Street Smith's Plan





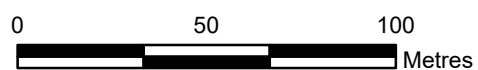

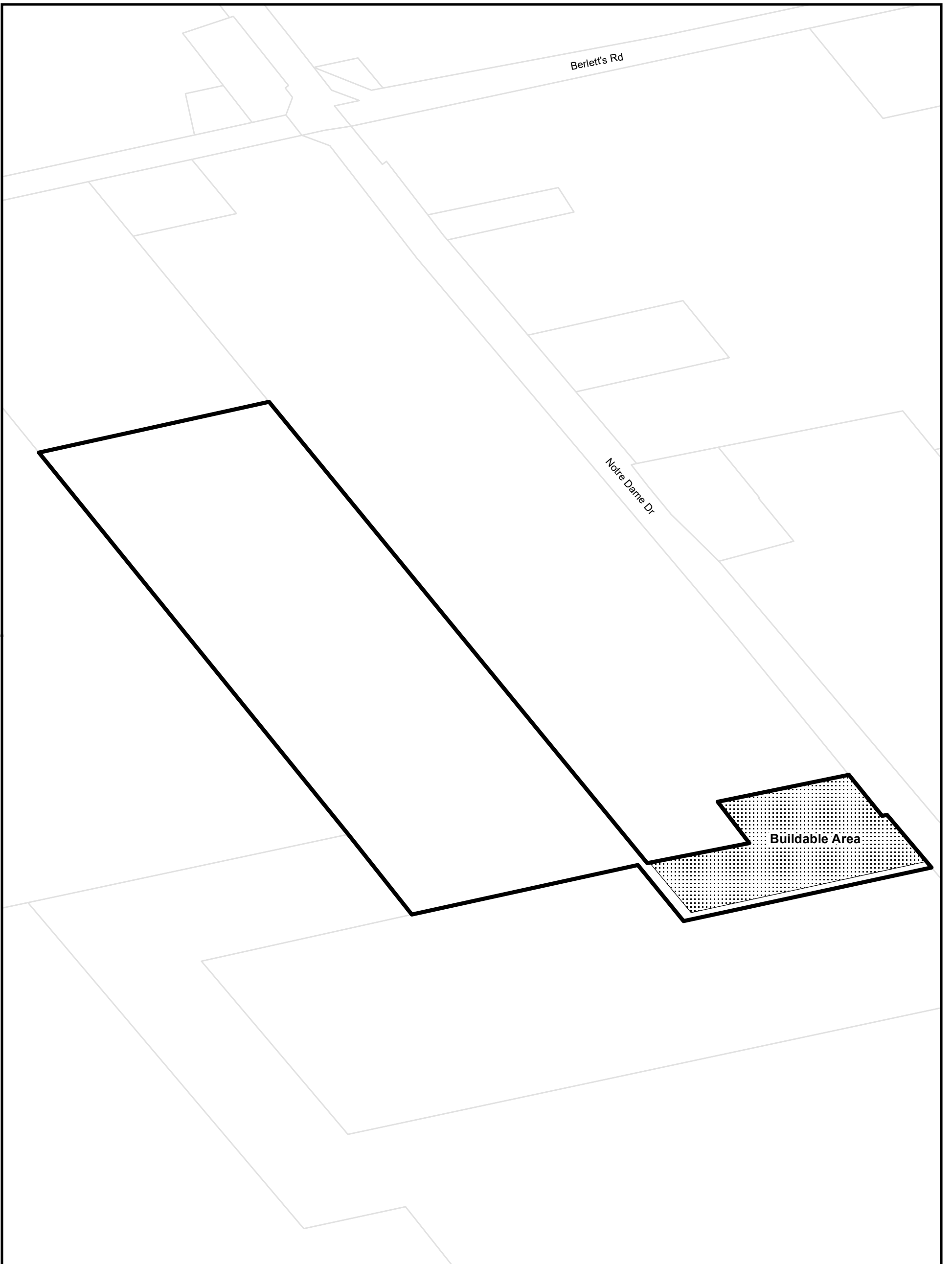
