## **Summer Day Camps during COVID-19**

The Township of Wilmot's priority is the safety and well-being of our camps and staff, while creating an enjoyable experience for our campers. Due to the COVID-19 Pandemic new protocols and practices will be in place.

What You and your Children can expect at Township of Wilmot Camps:

- All camps will be hosted at the Wilmot Recreation Complex.
- Maintaining a cohort size based on Provincial legislation, who stays together to minimize risk, with the same leaders for the duration of the week.
- Attempting to place siblings in the same group to limit household exposure.
- There will be no offsite field trips, or on-site special guests.
- COVID-19 Screening will occur every morning including health questions.
  Please note that this screening can be done from home by parents at
  COVID Screening form Facility visitors Township of Wilmot. If this is not complete prior to attending camp, it will be required to be completed upon the arrival at the entrance.
- To minimize risks, parents or guardians will not be permitted beyond the outside screening table.
- Increased hygiene and cleaning practices including:
  - o Increased frequency and supervision of hand hygiene.
  - Increased frequency of cleaning high contact surfaces a minimum of every 2 hours.
- Campers will have their own table space a minimum of 6 feet or 2 metres from other participants and will have all their own supplies for craft materials supplied by the Township of Wilmot. Any shared supplies will be disinfected between usage following the disinfectant product directions.
- Masks will be required indoor spaces when physical distancing of 6 feet or 2 meters cannot be maintained; or in the event of a medical emergency.
- Face Masks should be changed if visibly soiled, damp, or damaged.
- Staff will continue to administer minor first aid wearing the appropriate
  Personal Protective Equipment of Township issued mask, gloves and eye

protection including face shields or safety glasses. In the event that 9-1-1 is called, the Camp Leader of your child's cluster will administer First Aid until the paramedics arrive.

- Gloves are not permitted to be worn by campers.
- Indoor singing will not be permitted.
- Three, 30 minute optional swimming timeslots will occur each week on Tuesday, Wednesday and Thursdays, providing it is permitted in the COVID-19 Framework in which the Region of Waterloo is in, at the time of camp.
- Physical Distancing of 6 feet or 2 meters is always mandatory by campers and staff.
- Sharing or trading of food is strictly forbidden.
- There is a designated space at each camp location should any persons show symptoms or not feel well. The person will be removed from the camp area and into the first aid room and given a new disposable mask to wear.
   Parents will then be called to get their camper, and will be notified that their camper should be tested for COVID-19 and cannot return to camp until they are symptoms free for a period of 48 hours, have a negative test result or have a doctor's note saying they may return to the program.
- Should someone in camp tests positive for the COVID-19 Virus; there is a protocol laid out by the Township of Wilmot in conjunction with the Region of Waterloo Public Health Unit which will be adhered to.
- There will be no virtual camps run by the Township of Wilmot.

These practices and protocols are subject to change based on the direction of the Provincial and Federal Governments, and the Region of Waterloo Public Health Unit.
