- ☐ SEPTIC LOCATE AND SEPTIC AUDIT INFORMATION MUST BE SUBMITTED AS PART OF A COMPLETE PERMIT APPLICATION (FOR SYSTEMS REGULATED BY OBC). (SEPTIC LOCATES AND AUDITS MUST BE PERFORMED BY A LICENCED SEPTIC INSTALLER AND BE WITNESSED BY A BUILDING INSPECTOR - 24HRS NOTICE REQUIRED.)
